RE: 2023 IWF Grand Prix 1 – Preliminary Memorandum

The 2023 IWF Grand Prix 1 will take place in Havana, Cuba from June 8-18, 2023. The International Weightlifting Federation provided us with preliminary information on March 1 following an unannounced change of date for the event. Given the location of this competition, we expect several delays in receiving the competition regulation and other details related to the planning process. In the interest of time, we are therefore releasing this preliminary memorandum to help you prepare in advance of any deadlines that may become imminent. Funding levels for this competition have not yet been confirmed.

Qualification Standards

To qualify, athletes must achieve the following totals in competition:

Whereabouts

As an Olympic qualification event, Article 5.5.16 of the IWF Anti-Doping Rules and Regulations requires that all athletes who wish to participate file Whereabouts for the entire 3-month period prior to the start of the competition (i.e., starting March 8, 2023) through to the final date of the competition (inclusive) to be eligible for selection to Team Canada. Athletes who have not filed Whereabouts by the deadline set by the IWF will not be considered for selection.

We will provide additional information on the competition as soon as it becomes available.
